7. Tenant(s) agree that agent or its agents may enter the premises for effecting repairs and/or maintenance or for other necessary purposes.

Bed and Bay Hanalei is held harmless and will not be held liable or responsible for any disaster, act of God, accident, or unforeseen event that may affect the vacation rental, and such an event may cause this vacation rental agreement to be null and void and rent, tax and deposit may be refunded to the tenant(s) accordingly.
9. Acceptable forms of payment are personal check (more than 30 days prior to arrival only), cashier's check, money order, travelers' checks, or cash. We are unable to accept credit card payment.
